SUBJECT: SOCIAL PLANNING COMMITTEE WORK PLAN FOR 2024-2025

PURPOSE: To outline the activities of the Social Planning Committee for 2021-2023 and identify work plan initiatives for 2024 and 2025.

RECOMMENDATION

THAT the Social Planning Committee's work plan for 2024-2025 contained in the report titled "Social Planning Committee Work Plan for 2024-2025" dated May 22, 2024, be endorsed.

1.0 POLICY SECTION

The activities and initiatives of the Social Planning Committee (SPC) align directly with the vision, goals and strategic priorities of the *Burnaby Social Sustainability Strategy* (2011) and in particular, its three main goals:

- Community Inclusion: Burnaby will be an inclusive community.
- **Community Livability**: Burnaby will continue to be liveable for those who live, work, learn, play and visit.
- **Community Resilience**: Burnaby will be a resilient community, able to adapt and thrive in times of change.

The activities and initiatives also align with the following Council-adopted policies and plans/strategies:

- Corporate Strategic Plan (2022);
- HOME: Housing and Homelessness Strategy (2021);
- Child Care Action Plan (2021);
- Equity Policy (2020);
- Environmental Sustainability Strategy (2016);
- Economic Development Strategy (2007); and
- Official Community Plan (1998).

2.0 BACKGROUND

As identified in the Terms of Reference, the committee will advise on a variety of social issues including, but not limited to: leasing space at the City's Community Resource Centres, the needs of seniors, youth, families, ethnic groups, 2SLGBTQIA+, persons with disability, and socio-economic equity issues. The SPC will also be responsible for

making recommendations regarding inclusivity initiatives as they relate to the aforementioned groups^[1].

The SPC approved the work plan for 2021-22 on May 4, 2021. The purpose of this report is to provide information on the activities of the SPC in 2021-2023 and outline key social planning initiatives planned for 2024 and 2025.

3.0 GENERAL INFORMATION

3.1 2021-2023 SPC Activities

An overview of the activities undertaken by the SPC from 2021-2023 is provided in Attachment 1. The 2021-2023 work plan and related initiatives are summarized in the table below.

Key activities are anticipated to include:
