1.0 POLICY SECTION

2.0 BACKGROUND

The City of Burnaby and Western Economic Diversification Canada (WD) entered into an agreement in August 2021, which aims to enhance the City's emergency response capacity by establishing a new fire hall near the Burnaby Terminal, the terminus of the Trans Mountain pipeline. The agreement outlines WD will provide funding to the City at 59%, up to a maximum of \$30.0 million until March 31, 2037 (15 years) for eligible expenditures. Funding is being utilized for operational requirements (such as firefighter salaries & benefits, training, etc.), Firehall #8 feasibility studies & conceptual design costs (capital), and the procurement of emergency response units (capital) for the new facility. The City's current funding structure for Firehall #8 is 59% WD grant-funded, with the remaining 41% covered by the Gaming Reserve for operating expenses and a combination of Community Benefit Bonus Reserve (Fire Hall #8 construction costs) and statutory capital reserve funds (vehicles/equipment) for capital expenses.

3.0 GENERAL INFORMATION

The City is required to submit claims on a semi-annual basis (June and December) and to provide quarterly forecast for WD to review and audit the City's expenditure before the release of grant payments to the City. To date, the City has submitted four claims over the past two years. The following table provides a detailed breakdown of each claim, divided into operating and capital components with the grant received at 59%.

As of January 1, 2024, the City has claimed a total of \$4.8 million, with \$25.2 million outstanding against the remaining 13 year term.

5.0 FINANCIAL CONSIDERATIONS

As mentioned in previous sections of this report, Firehall #8 operations are currently being funded by the Gaming Reserve and the WD grant. The purpose of the Gaming Reserve is to provide funding to expenditures that serve to protect or improve Burnaby's environment such as public safety, beautification, heritage, international relations or arts & culture. However, funding Firehall #8 operating expenditures with the Gaming Reserve may not be sustainable. Therefore, alternative possible sources of funding will be discussed with Council during the budget process.
