# 7. <u>INFORMATION REPORTS</u>

# 7.1 VERBAL REPORT: INSIDE THE CITY ARCHIVES AND THE BURNABY VILLAGE MUSEUM

Julia Alforde, Acting City Archivist and Jane Lemke, Museum Curator, provided a PowerPoint presentation to highlight the functions and mandates of the City of Burnaby Archives and the Burnaby Village Museum (BVM).

The speakers highlighted the differences between museums and archives and the respective roles they play within the community, and provided an overview of history of the Burnaby Historical Society, the Village Museum (now known as the Burnaby Village Museum), and the City of Burnaby Archives.

- J. Alforde provided an overview the life cycle of City records, which are determined by the City's Records Retention and Classification Schedule.
- J. Lemke advised the goal of the BVM is to use its resources to welcome and help the community tell their stories and share knowledge.

In closing, the speakers highlighted individual projects the Burnaby Archives and BVM are working on, and projects they are working collaboratively on, which include museum exhibits, publications, community record donations and the Heritage Burnaby website.

### 8. CORRESPONDENCE

#### 8.1 Sean Sallis-Lyon - Re: Telus Boot Preservation

\*Commissioner Murphy returned at 6:12 p.m.

Correspondence was received from Sean Sallis-Lyon inquiring whether the Telus Boot could be preserved by giving it a heritage designation.

Staff advised the BC Tel (now known as Telus) building known as the "boot" is considered a landmark by some in the community. It was constructed in 1976. An application for redevelopment of the site is in progress, and includes the intent to retain the "boot" and construct new high-rise buildings to the site.

The Commission noted that while the building is unique and one of Burnaby's early towers, they did not feel it should be listed as a heritage resource on the Burnaby Community Heritage Register or heritage inventory.

Staff undertook to respond back to the writer.
