SUBJECT: CA – SFU EMERGENCY ROUTE ROADWORKS CA-3298

PURPOSE: To obtain Council approval for a Contract Award (CA) for the SFU

Emergency Route Roadworks project.

RECOMMENDATION

THAT a contract award to GPM Civil Contracting Inc., for an estimated total cost of \$2,105,250 including GST in the amount of \$100,250 as outlined in the report titled "CA – SFU Emergency Route Roadworks CA-3298" dated June 24, 2024 be approved; and

THAT final payment be based on the actual quantities of services delivered and unit prices as tendered.

1.0 POLICY SECTION

The City's Procurement Policy requires that contracts for goods and services, and construction with values over \$1,000,000 be approved by Council following a competitive procurement process.

2.0 BACKGROUND

Two tenders ranging from \$2,105,250 to \$2,145,056 were received by the closing time on May 30, 2024. The lowest tenderer, GPM Civil Contracting Inc., has completed previous projects under contract to the satisfaction of the City. Review by City staff and our consultant indicates the contractor has the necessary equipment and personnel to successfully complete the work required under this contract. The General Manager Engineering concurs with the recommendation.

3.0 GENERAL INFORMATION

The scope of this project includes constructing a 4 meter paved emergency route to connect Simon Fraser University and Mintara Restaurant parking lot in Burnaby Mountain Park. The paved route will also include a gas service connection to the Mintara Restaurant and communication conduits for future use. The emergency evacuation route is a priority project designed to allow downhill evacuation for users of all ages and abilities, as well as ambulance usage in emergency situations on Burnaby Mountain Park.

4.0 COMMUNICATION AND COMMUNITY ENGAGEMENT

Tender CA-3298 SFU Emergency Route Roadworks (Attachment 1) was publicly advertised. Upon closing, the City received a total of two submissions.

5.0 FINANCIAL CONSIDERATIONS

Funding for this capital work is included in the 2024 – 2028 Financial Plan under Engineering – Transportation, Walking –SFU Alternate Access Route with a budget of \$2,000,000. As bid prices received were higher than estimated a plan reallocation in the amount of \$500,000 has been made from the Walking – New Sidewalks Program – South Windsor project which is currently not started and will be reviewed in the next budget cycle. This contract award will be accommodated under WBS number: EMF.3298 (\$2,005,000 excluding GST).

This project will be funded by the Community Benefit Bonus Reserve which has the following commitments (excluding GST):
