APRIL RETIREMENTS

Mike Kelly

Mike retired from employment with the City on April 30, 2024, after 33 years of service. He commenced employment with Burnaby on March 16, 1992, with the Parks, Recreation & Culture Department. From July 7, 2008, to his retirement, Mike held the position of Foreman 1 - Waterworks.

Bill Schild

Bill retired from employment with the City on April 30, 2024, after 37 years of service. He commenced employment with Burnaby on September 15, 1986, with the Parks, Recreation & Culture Department. From August 21, 1988, to his retirement, Bill held the position of Arena Service Worker.
