## **Re:** Notice of Proposed Recommendation for Designating Order – Transit-Oriented Area(s)

Pursuant to Section 585.52 of the Local Government Act, the City of Burnaby Council must, by bylaw, designate each transit-oriented area in respect of the City of Burnaby and give written notice to the minister, together with a copy of the bylaw, as soon as practicable after adopting that bylaw.

Pursuant to Section 585.53 of the Local Government Act, on the recommendation of the minister, the Lieutenant Governor in Council may make an order designating a transit-oriented area in respect of the City of Burnaby. The minister may make such recommendation if:

- (a) The minister is satisfied that:
  - (i) the City of Burnaby has failed to designate the transit-oriented area, or
  - (ii) the transit-oriented area designated by the City of Burnaby does not meet the requirements under the Act,
- (b) the minister has given notice to the City of Burnaby of the minister's proposed recommendation, and
- (c) the City of Burnaby Council does not designate the transit-oriented area in accordance with the notice.

This correspondence is notice to the City of Burnaby that I am satisfied that it has failed to designate one or more prescribed transit-oriented area(s) in respect of it. Specifically, I propose to make a recommendation in respect of the following transit-oriented area(s):

Pursuant to Section 585.52 (3) (c), of the Local Government Act the City of Burnaby must, no later than October 31, 2024, designate the transit-oriented area(s) in accordance with this notice and give written notice to the Minister of Transportation and Infrastructure in accordance with Section 585.52 (4) of the Local Government Act.
