- SUBJECT: CI ASPHALT PAVING SERVICES ENGINEERING DEPARTMENT
- **PURPOSE:** To obtain Council approval to award a Contract Increase (CI) for Asphalt Paving Services Engineering Department.

RECOMMENDATION

THAT a contract increase to Blackrete Paving Ltd., for an estimated amount of \$1,065,750 including GST in the amount of \$50,750 as outlined in the report titled "CI – Asphalt Paving Services – Engineering Department" dated October 07, 2024 be approved; and

THAT final payment will be based on the actual quantity of goods and services delivered and unit prices as submitted.

1.0 POLICY SECTION

The City's Procurement Policy requires Council approval for change orders, which individually or when accumulated with prior change orders, increases the total value of the contract by \$1,000,000.

2.0 BACKGROUND

On July 15, 2022, the City awarded a contract to Blackrete Paving Ltd. for Asphalt Paving Services - Engineering Department on an as and when need basis, for an estimated value of \$210,000 including GST in the amount of \$10,000. The original contract term was from July 15, 2022 to March 31, 2024. The contract was extended from April 1, 2024 to March 31, 2025 with two individual extension option years remaining at the sole discretion of the City.

The asphalt paving contract is a multi-year contract with external contractors to provide paving and concrete services to compliment City forces work.

3.0 GENERAL INFORMATION

This contract increase of \$1,065,750 including GST in the amount of \$50,750 is required to cover work until the end of the contract term March 31, 2025.

Since the award of the contract, there have been eight contract increases for a value of \$2,417,310 including GST in the amount of \$115,110. These contract increases have been a result of the City experiencing an increase in the amount of asphalt paving requirements due to emergency repair work that cannot be predicted, and the growing need for storm sewer extensions and watermain installations.

The total estimated contract value is \$3,693,060 including GST in the amount of \$175,860.

The General Manager Engineering concurs with this recommendation.
