1. CALL TO ORDER

Mayor Hurley called the Open Council meeting to order at 5:07 p.m.

2. LAND ACKNOWLEDGEMENT

Mayor Hurley recognized the ancestral and unceded homelands of the həndəminəm and Skwxwú7mesh speaking peoples, and extended appreciation for the opportunity to hold a meeting on this territory.

3. ADOPTION OF AGENDA

3.1 Open Council Meeting Agenda for September 23, 2024

Resolution No. 2024 - 388

Condolences - Don Wrigley

Mayor Hurley, on behalf of Council, expressed condolences to the Wrigley family. The following are the Mayor's remarks:

"I would like to take a moment to pass our condolences on to the Wrigley family on behalf of the entire community of Burnaby.

Earlier this summer, Don Wrigley passed away at the age of 100.

Dorothy Wrigley, his wife and partner in so much of his work, passed away in 2023 – the year of their 75th wedding anniversary.

Don was an avid volunteer, a generous donor to a variety of causes, and an active contributor to community life in Burnaby through his church and volunteer work.

His lifelong work was recognized by the City in 1990, when he won the Kushiro Cup as Burnaby's Citizen of the Year.

He played an instrumental role in bringing the Parker #119 carousel to the Burnaby Village Museum, as part of the Friends of the Carousel organization. He served as chair when the group purchased and restored the carousel, and he was also the chief fundraiser – helping to bring together over \$330,000 in pledges and additional in-kind donations.

And he remained active in the "Friends of the Carousel" group - long after the carousel was opened at the Museum.

Don also helped to initiate the restoration of Interurban 1223. The historic 1912 B.C. Electric Interurban tram is now on display at the Burnaby Village Museum.

Originally born in the United Kingdom, Don and Dorothy came over to Canada in 1957.

She enjoyed a successful secretarial career, serving as Executive Secretary to four of Burnaby's mayors before retiring in 1986.

I can tell you firsthand, that is not an easy job.

Both Don and Dorothy joined the United Church after moving to Canada, and later, the Deer Lake United Church.

Together, Don and Dorothy helped build Burnaby into a better community.

We are grateful for their years of service, and for their generosity and passion for their community.

Our condolences to their family and friends. Thank you."

Emma Gibbons, CEO, and Ryan Gandy, Board Member, Volleyball BC, appeared before Council providing an update on the Harry Jerome Sports Centre facility.

The speakers provided a history of the organization as well as last year's statistics and information on the cost of the roof replacement and the conditions of their lease agreement.

The General Manager Lands and Facilities advised that a report will be forthcoming to Council before the end of the year.

6.1 CBBR - CHILD CARE GRANT FUNDING

The General Manager Planning and Development submitted a report providing information on Provincial funding received for two City child care centres and an update on a financial commitment with the Burnaby School District.

6.2 REZ #21-33 - 3819 AND 3841 CANADA WAY - MIXED USE DEVELOPMENT

The General Manager Planning and Development submitted a report seeking Council authorization to forward REZ #21-33 to First and Second Reading at a future Council meeting. The purpose of the proposed zoning bylaw amendment is to facilitate the construction of a mixed-use development comprised of one six-storey building with commercial uses at grade and residential units above.

THAT the items listed in **Attachment 3** – Rezoning Prerequisites to the report be established as prerequisites to consideration of Final Adoption of the Rezoning Bylaw for REZ #21-33.

The original recommendation was moved and seconded, and Councillor Gu then introduced an amendment to be added as the final clause as follows and indicated with underline:

THAT Council direct staff to negotiate with the Ministry of Transportation and Infrastructure (MOTI) on cost-recovery of provincial fees and permits, considering the City is building the Burnaby Lake Overpass due to Highway 1, which is under provincial jurisdiction.

- ensure inclusive and gender-neutral language is used;
- allow for naming of living individuals except current City elected officials or staff and by including living individuals the following amendments would be required:
 - discussions regarding information related to preliminary naming considerations continue to be held in closed pursuant to section 90 of the *Community Charter*;
 - staff must obtain consent from the named individual, and if the naming is posthumous, the person's immediate family or executor of the estate must provide consent;
 - include guidelines on how to decommission a named asset; and
 - include plaque installation when a new civic asset is named for an individual, and ensure biographical information is easily accessible to the public when visiting the asset.
