1. CALL TO ORDER

Mayor Hurley called the Open Council meeting to order at 5:07 p.m.

2. LAND ACKNOWLEDGEMENT

Mayor Hurley recognized the ancestral and unceded homelands of the həndəminəm and Skwxwú7mesh speaking peoples, and extended appreciation for the opportunity to hold a meeting on this territory.

Announcement - Passing of Murray Sinclair

Mayor Hurley expressed condolences at the passing of Murray Sinclair. The following were the Mayor's remarks:

"Today, we received the sad news that Justice Murray Sinclair has passed away.

Murray Sinclair, a champion for human rights, justice and truth, served as the chief commissioner of the Truth and Reconciliation Commission of Canada.

Justice Sinclair's contributions to the Truth and Reconciliation Commission are significant – but they represent only a small part of his lifetime of service to this country.

A member of the Peguis, First Nation, he was Manitoba's first Indigenous judge, served as a Senator and was made a companion of the Order of Canada.

In his final speech as Truth and Reconciliation Commission Chairman, he urged all Canadians to work towards reconciliation.

"We have described for you a mountain. We have shown you the way to the top," he said. "We call on you to do the climbing."

He was known for his brilliant legal mind and as a fierce advocate for his courage and dedication to bringing attention to the legacy of residential schools, but above all he was known for his kindness to everyone he met.

On behalf of the City of Burnaby, I would like to share our deepest condolences to the Sinclair family and his friends."

THAT the City Solicitor be authorized to bring forward amendments to Burnaby Consolidated Fees and Charges Bylaw for 2024 fees and Burnaby Consolidated Fees and Charges Bylaw, Amendment Bylaw No. 2, 2024 for fees effective January 1, 2025, substantially as set out in **Attachment 1** of the report;

THAT the City Solicitor be authorized to bring forward amendments to Burnaby Development Procedures Bylaw 2022, substantially as set out in **Attachment 1** of the report;

THAT the City Solicitor be authorized to bring forward a bylaw to repeal Burnaby Liquor Licence Application Fee Bylaw, 2001, as described in Section 3.2 of the report;

THAT the City Solicitor be authorized to discharge existing liquor and cannabis related covenants, in accordance with Section 3.5 of the report;

THAT a Public Hearing not be held for the proposed amendments to Burnaby Zoning Bylaw, 1965 described in the report, as they are consistent with the Burnaby Official Community Plan; and

THAT staff be directed to set a fee of \$5,000 for the licence for <u>cannabis stores</u>.
