1.0 POLICY SECTION

The Burnaby Plaza Paver Dedication Ceremony aligns with and is supported by the following Council-adopted policies and plans/strategies: Equity Policy (2020) and Corporate Strategic Plan (2022).

2.0 BACKGROUND

The Plaza Paver Dedication Ceremony recognizes and honours individuals, groups and businesses that make significant contributions to our community. Historically, the Paver Dedication Ceremony was planned once every two years and pavers were laid in City Hall Plaza to commemorate annual awards for Kushiro Cup, Burnaby Sports Hall of Fame Inductees, and Burnaby Business Hall of Fame Inductees.

The last ceremony took place in 2018 and honoured recipients from 2016 and 2017.

Since the last ceremony, there are in total 43 pavers to be laid in celebration of the honourees from 2018 – 2024, at a future Plaza Pacer Dedication Ceremony

3.0 GENERAL INFORMATION

As pavers were last ordered in 2018, a new paver supplier will have to be sourced. Previously, the cost was estimated at approximately \$100 per paver and it is expected that the price per paver would now be estimated a minimum of \$250 per paver installed.

Once the pavers are ordered, arrangements for the installation of the paver stones will be undertaken. This generally takes a few months from start to finish.

If the ceremony is approved to take place in 2025, planning would begin for a September event that would see the award recipients invited to attend.

4.0 COMMUNICATION AND COMMUNITY ENGAGEMENT

The event would be open to the public and Marketing & Corporate Communications staff would provide information and updates on the event through the City's various communications platforms.

5.0 FINANCIAL CONSIDERATIONS

The total cost for the required 43 pavers listed above is anticipated to be at minimum \$10,750. Staff are currently investigating local suppliers and associated costs. The current budget for the pavers is \$12,500.
