5.1 Delegation: Simon Fraser University – Re: Simon Fraser University – A Vital Part of the City of Burnaby's New Official Community Plan Speakers: Jennifer Sanguinetti, AVP Facilities and Campus Planning, and James Beresford, Executive Director and Chief of Staff, Simon Fraser University

The speakers provided a PowerPoint presentation on the 2065 Burnaby Campus Master Plan and its alignment with the Burnaby Official Community Plan.

5.2 Delegation: BC Housing – Re: Stratford Gardens - Community Benefits/Case for More Homes

Speakers: Nicholas Hardy, Development Manager, BC Housing, and Michael Mortensen, Director of Liveable City Planning Ltd.

The speakers provided a PowerPoint Presentation on the redevelopment application and outlined opportunities for additional homes at Stratford Gardens.

The General Manager Planning and Development advised that the Item 6.2 OCP Amendment – 6005 Pandora Street (Stratford Gardens) of the February 12, 2025, Planning and Development Committee meeting would determine the land use designation for the subject site through the Burnaby 2050 Official Community Plan.

6. <u>ADMINISTRATIVE REPORTS</u>

6.1 REVIEW OF CRITERIA FOR CBBAHR GRANT REQUESTS

The General Manager Planning and Development submitted a report seeking Council approval of revised criteria for the use of the Community Benefit Bonus Affordable Housing Reserve (CBBAHR) for Community-Sponsored and City-Initiated developments and considering grants to support the acquisition of existing purpose-built market rental buildings by non-profit organizations.

THAT the revised criteria for consideration of CBBAHR grants for community-sponsored developments as outlined in the report titled "Review of Criteria for CBBAHR Grant Requests", dated February 12, 2025, and detailed in Attachment 3 to the report, be approved;

THAT the City provide the required off-site servicing for City-initiated developments on City-owned lands that are leased to other orders of government, including the Provincial Rental Housing Corporation and Metro Vancouver Housing Corporation, with the site servicing cost to be funded through the CBBAHR; and

THAT acquisitions of existing purpose-built market rental housing buildings by not-for-profit organizations that secure funding from the provincial Rental Protection Fund and secure rents at levels affordable to those with incomes at or below BC Housing's Housing Income Limits (HILs) be eligible for Council consideration of a CBBAHR grant.

6.2 OCP AMENDMENT - 6005 PANDORA STREET (STRATFORD GARDENS)

The General Manager Planning and Development submitted a report providing the results of public consultation on the proposed Official Community Plan (OCP) amendment and seeking authorization to determine the land use designation for the subject site through the Burnaby 2050 OCP update and not through the current OCP amendment process.

THAT the proposed OCP amendment for 6005 Pandora Street not proceed at this time, as outlined in the report titled "OCP Amendment – 6005 Pandora Street (Stratford Gardens)", dated February 12, 2025.
