BYLAW NO. 14739

A BYLAW to establish the annual charge for each foot of taxable foot-frontage to be specially charged against parcels of land benefitting from certain local area service works

WHEREAS the local area service works more particularly described in Schedule Numbers 1 to 3 of Schedule "A" inclusive hereunto annexed have been duly constructed pursuant to the provisions of Division 5 of Part 7 of the *Community Charter*:

AND WHEREAS the total actual foot-frontage, the total taxable foot-frontage and the sum required to be raised annually during the period therein set forth are stated in the said Schedules in respect of each of the said works;

AND WHEREAS parcel tax assessment rolls have been duly prepared, confirmed and authenticated in respect of the said works;

NOW THEREFORE the Council of the City of Burnaby ENACTS as follows:

- 1. This bylaw may be cited as **BURNABY LOCAL SERVICE TAX BYLAW 2025.**
- 2. There is hereby levied and charged against those parcels of land abutting or benefitting from the local area service works more particularly described:
- (a) in Schedule Number 1 of the Schedule "A" attached to this bylaw, during the years 2025 to 2039 inclusive; and
- (b) in Schedule Numbers 2 and 3 of the Schedule "A" attached to this bylaw, during the years 2025 to 2034 inclusive,

a parcel tax that shall be the product of the taxable foot-frontage of each parcel assessed and shown on the parcel tax assessment roll, together with the annual rate per taxable front foot as set out in the said Schedule for the particular local area service work described therein.

3. The frontage measurements for works described in the Schedule "A" attached to this bylaw shall be calculated in accordance with Section 4 of the Burnaby Local Improvement Charges Bylaw 1985 as it read after adoption of Bylaw No. 14091.
