## CITY OF BURNABY BYLAW NO. 14754

A BYLAW to amend Burnaby Zoning Bylaw

The Council of the City of Burnaby ENACTS as follows:

- 1. This Bylaw may be cited as **BURNABY ZONING BYLAW 1965**, **AMENDMENT BYLAW NO. 11**, 2025.
- 2. Burnaby Zoning Bylaw 1965, as amended, is further amended:
  - (a) by repealing subsection 301.1(18) in its entirety and replacing it with the following:
    - "(18) Liquor stores, provided each liquor store is located more than 1.0 km (3,281 ft.) away from another liquor store within the City of Burnaby."
  - (b) by repealing subsection 301.1(19) in its entirety and replacing it with the following:
    - "(19) Cannabis stores, provided each cannabis store is located more than 1.0 km (3,281 ft.) away from another cannabis store within the City of Burnaby."
  - (c) by repealing subsection 302.1(24) in its entirety and replacing it with the following:
    - "(24") Liquor stores, provided each liquor store is located more than 1.0 km (3,281 ft.) away from another liquor store within the City of Burnaby."
  - (d) by repealing subsection 302.1(25) in its entirety and replacing it with the following:
    - "(25) Cannabis stores, provided each cannabis store is located more than 1.0 km

- (3,281 ft.) away from another cannabis store within the City of Burnaby."
- (e) by repealing subsection 302.1A(2) in its entirety and replacing it with the following:
  - "(2) Liquor stores, provided each liquor store is located more than 1.0 km (3,281 ft.) away from another liquor store within the City of Burnaby."
- (f) by repealing subsection 302.1D(2) in its entirety and replacing it with the following:
  - "(2) Liquor stores, provided each liquor store is located more than 1.0 km (3,281 ft.) away from another liquor store within the City of Burnaby."
- (g) by repealing subsection 302.1E(2) in its entirety and replacing it with the following:
  - "(2) Cannabis stores, provided each cannabis store is located more than 1.0 km (3,281 ft.) away from another cannabis store within the City of Burnaby."
- (h) by repealing subsection 303.1(34) in its entirety and replacing it with the following:
  - "(34) Liquor stores, provided each liquor store is located more than 1.0 km (3,281 ft.) away from another liquor store within the City of Burnaby."
- (i) by repealing subsection 303.1(35) in its entirety and replacing it with the following:
  - "(35) Cannabis stores, provided each cannabis store is located more than 1.0 km (3,281 ft.) away from another cannabis store within the City of Burnaby."
- (j) by repealing subsection 303.1A(2) in its entirety and replacing it with the following:

- "(2) Liquor stores, provided each liquor store is located more than 1.0 km (3,281 ft.) away from another liquor store within the City of Burnaby."
- (k) by repealing subsection 303.1H(2) in its entirety and replacing it with the following:
  - "(2) Liquor stores, provided each liquor store is located more than 1.0 km (3,281 ft.) away from another liquor store within the City of Burnaby."
- (l) by repealing subsection 303.1I(2) in its entirety and replacing it with the following:
  - "(2) Cannabis stores, provided each cannabis store is located more than 1.0 km (3,281 ft.) away from another cannabis store within the City of Burnaby."
- (m) at subsection 310.3, by repealing the row entitled "Retail" and replacing it with the following:
